The timeline/locations is as follows:

Week 1 Songwriting

January 16 - 4:00-6:30pm

Location: Lakeshore Arts Storefront Gallery (2422 Lake Shore Blvd W).

Week 2 Pre-Production (Offsite)

January 23 - 4:00-6:45pm,

Location: 71 Judson Ave

We will meet at Lakeshore Arts at 4:00pm sharp and walk over to Nick's studio. To ensure that we have the full two hours for the program we will be leaving to walk back at 6:30, arriving at Lakeshore Arts at 6:45. Those who do not need to be picked up can go home straight from the studio.

Week 3 Recording (Offsite)

January 30 - 4:00-7:45pm,

Location: 71 Judson Ave

We will meet at Lakeshore Arts at 4:00pm sharp and walk over to Nick's studio. **This final workshop is extended by one hour** and we will be arriving back at Lakeshore Arts at **7:45pm**. Those who do not need to be picked up can go home straight from the studio.

As always cost for this workshop is FREE, however because of the limited amount of space and time the **workshop is limited to 20 participants**. *To ensure your spot the first 20 to hand in their permission forms (electronically/in-person) will be registered for the workshop.*
